## **Treasurer's Report:** Parent Advisory Council (PAC) Wednesday, June 15, 2016

Another strong year of fundraising has left us in great shape to continue the regular funding levels that we have been able to provide our school's budget.

Our budget was \$11,948 for fundraising, donations and support from community organizations. The Halloween Dance, Christmas Craft Fair and Spring Carnival brought in \$3218 (including concession). Individual fundraisers (seeds, pasta, purdys, tea, chocolate, etc) brought in \$883. The coupon books brought in \$860. We received \$599 from Village Food's milk money program. We still expect revenue from the Staples school supplies fundraiser. Our spring break metal drive did not bring in as much revenue as we expected, however we should still come in above target.

Our budget for spending was \$11,842 and we are close to that. The PAC continued funding of extracurricular and special programs and was again able to fund some "special purchases" this year; Wontorana Drummers, volunteer shirts, the clay whole-school mural project, and a new water fountain/bottle refill station. The larger expenditures are guest speakers/concerts, classroom literacy and resources, classroom supplies and activities and art supplies. The PAC also funds the grade 5 day at Camp Thunderbird.

**Food Services**: A very busy year for food services and the 15/16 hot lunches and activities brought in approximately \$2000, and there are still hot lunch days this year.

**Gaming Account**: We receive a grant of \$20/child which currently funds \$250 for a "Saseenos Alumni" bursary at EMCS, \$750 for guest speakers, cultural events and concerts as well as the majority of the bussing amounts.

Application has been submitted for 16/17 gaming funds. Annual Gaming Funds Report – due Nov 30.

**Emergency Preparedness**: We did not receive many parent contributions (we need someone to ensure the letters go out early and maybe a follow up... so busy in September though). We purchased 30 kits for \$408 and received \$90 in donations. That is okay as we decided the PAC would ensure that there is a kit per child regardless.

**Term Deposit / GIC**: The \$25,000 GIC matured in May and has been rolled over to a daily savings account. This amount is separate from our general account and not included in annual budget. We have flexibility to lock it or a portion of the balance in, however interest rates are very low right now. We looked at information and rates from Investors Group, CIBC and TD at the April executive meeting in and determined priority to low risk options with some return of annual interest.

Option A: a short term GIC with maybe 1% interest to see how interest rates change in the next 12 to 15 months. TD has a 15 month GIV with 1.1% interest available as of May 4 but it changes daily. Any long term GIC would be inadvisable at this point as interests rates are next to nothing.

If we thought the funds might be needed, we could put some of the money in a cashable GIC at a lower interest rate, but as mentioned, this amount is not included in the annual budget and we have sufficient funds to cover a year or two. The Market rate GIC have possible higher interest rates but are locked in and the interest isn't paid until maturity so no yearly interest payments. Also those are not compound interest.

\*To re-invest our GIC we need the executives to have minutes of a meeting in which they discuss and approve the decision to purchase a GIC with TD, being specific about what GIC in what dollar value, those minutes need to be brought in to setup a profile with TD and setup signing authority etc. The GIC would be in the PACs name, not any one individual and would need a minimum of two people with signing authority.
